

# **UK Visa Information**

### Do you need a visa to study in the UK?

If you are a 'Non-Visa National' (such as all EU/EEA countries, Argentina, Brazil, Japan, Korea, Taiwan) you can enter the UK with a 'Visitor Visa'. This is issued on arrival and you can stay and study for up to 6 months. At arrival, you can enter through the e-gates and do not need to speak to immigration staff. There will be no stamp in your passport. If you want to study for more than 6 months you will need to apply for either a Short-term Study visa or a Student Visa before you travel – see details below.

If you are a '<u>Visa National</u>' (such as from China, Russia, Saudi Arabia, Turkey, UAE, Ukraine) you always need to apply for a visa before you travel. If your course is less than 6 months you can enter and study with a 'Visitor Visa'. If you want to study for more than 6 months you can apply for a 'Short–Term Study visa' (up to 11 months).

### Visa Types

#### **Visitor Visa**

A Visitor Visa allows you to:

- Study on a short course (including English language courses) for up to 6 months at an accredited school.
- Stay in the UK for up to 6 months

This is the most suitable visa for many of our students.

For under 18 year olds this is known as a Child Visitor Visa.

#### **Short-term Study Visa**

Frances King School of English is accredited by Accreditation UK which means we can support an application for a Short-term Study Visa.

A Short-Term Study visa allows those over 16 years old to:

Study on an English language course for up to 11 months at an accredited school

• Stay in the UK for the length of the course plus 30 days
You can apply for a short-term study visa up to 3 months before your date of travel and should get a decision within 3 weeks of application. Check the gov.uk visa processing times for more information.

To apply for this visa you must provide proof:

- of acceptance onto a course
- that you have enough money for your stay
- that you have money for your return journey

If you are under 18 years old you also need to show:

- you have booked your travel and accommodation
- you have permission from your parent or guardian
